**You are about to purchase a product that is not simple and may be difficult to understand.**

#### What is this product?

**Type** This product is a non-UCITS investment fund. It is a Retail Investor AIF (Alternative Investment Fund). The minimum initial subscription and subsequent subscription amounts are set at €10,000.

**Objectives** The Fund seeks to achieve its investment objective by investing on a diversified basis in transferable securities, such as equity securities and debt securities, and collective investment schemes (including exposure to alternatives such as property and forestry). Investments of the Fund will be subject to an ethical screening process.

**Intended retail investor** This product is intended for investors who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for 5 years. It is also designed to form part of a portfolio of investments.

**Maturity date** This product is open ended. However, the Manufacturer reserves the right to close the Fund should assets fall below €4,000,000.

#### What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Investing in collective schemes to gain exposure to alternatives increases liquidity risk as the schemes may have a limited number of redemption points. The fund does not pursue a sustainability mandate but is actively managed in a socially responsible manner. The Manager has integrated sustainability risks as part of its investment decision-making process. Stocks are subject to an ethical screen and the fund avoids stocks in conflict with global ESG norms. Accordingly, based on our current approach, the universe of investments available is more limited than others and this could result in performance that is better or worse than the performance of the other funds.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
