What is this product?

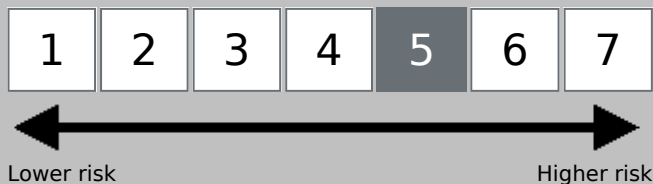
Type This product is a non-UCITS investment fund. It is a Retail Investor AIF (Alternative Investment Fund).

Objectives The Fund seeks to achieve its investment objective by investing on a diversified basis in equity securities and open-ended collective investment undertakings with an exposure to equities, with no particular focus on any one country.

Intended retail investor This product is intended for investors who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for 5 years. It is also designed to form part of a portfolio of investments.

Maturity date This product is open ended. However, the Manufacturer reserves the right to close the product, at one month's notice, should assets fall below €4,000,000 at any time one year post launch.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The fund is exposed to exchange rate volatility, as it holds assets denominated in multiple currencies. See prospectus for overall risk information.

While not pursuing a sustainable mandate or focus, the AIFM have integrated sustainability risks as part of its investment decision - making process.
